Approval of Minutes – 5/21/25: Jessica moved to amend the 5/21/2025 minutes to add her absence. Farah brought a motion to approve the amended minutes. Victor seconded. The amended minutes from the May 2025 meeting were approved.

Approval of Agenda: Molly moved to approve the agenda. Victor supported the motion, and it was approved without opposition.

Debrief of Farmer's Market Day - May 31st - Jessica reported there was a positive reception to the bike ride promotion and the bike light handouts and coloring books. Farah recommends that we get more handouts from SEMCOG. There might be an opportunity next year in which a member can submit an order to SEMCOG from both Farmington and Farmington Hills resident. Teresa recommended that perhaps the commission can purchase additional resources from SEMCOG. Jessica suggested that next year we move the booth so we don't have lot #31 due to the slope of the hill the table was on.

Debrief of Bike Ride and Community Fair - June 12 - Molly had positive feedback about the participation by TrvFit and they led the Ride in a stretch. TrvFit also promoted Farmington businesses. Somewhere between 8-12 riders attended. The helmets were donated to the Farmington Hills Fire Department Charity. The Commission will confirm and announce the July, August and September dates.

ALICE Training for Commissioners - Farah is awaiting dates from the Officer for September/October training dates. Suggested September 27, October 11, or October 18 to have enough time to promote across the Farmington/Farmington Hills commissions.

Summer Public Service Announcements: Molly will email and forward the July and August announcements for distribution. Any proposals for subject matter can be suggested to Molly.
