FEES: NON-REFUNDABLE FEE TO HOST/BOOK VOLLEYBALL TOURNAMENT: \$100 (including all 4 courts), plus \$100 per hour (minimum 3 hours for tournament).

The City of Farmington Hills and said organization agrees to rent courts on the date(s) and time(s) listed above, and agrees to the following:

1. During the term of the Agreement, the individual or organization shall procure and maintain a General Liability insurance policy, at its sole cost and expense, for the injuries to persons or damages to property that may arise from or in connection with the permitted use of the facility and the activities associated with it. The policy should name the City of Farmington Hills as "Additional Insured". The policy should be for a minimum of \$1,000,000 for bodily injury and property damage.
2. The individual or organization will not charge a parking fee, however, can charge an entrance fee. Outside concessions and vendors are not permitted.
3. The individual or organization will email tournament game schedule, a minimum of 1 week prior to event to: jvayis@fhgov.com; cpace@fhgov.com
4. Non-refundable deposit of \$100 is due at time of reservation*. Tournament only. Full payment for court use must be made a minimum of 10 working days after the tournament, check payable to City of Farmington Hills

and sent to: City of Farmington Hills Parks, Attn: Volleyball Court Reservation, 38111 Interchange Drive, Farmington Hills MI 48335.

5. No alcoholic beverages are allowed in the park.
6. Volleyball teams are not permitted to use soccer fields.
7. The individual or organization agrees to abide by all City and park ordinance/rules.
8. The individual or organization will provide the name and daytime phone number of the event's on-site contact person.

9. Individuals or organizations may rake courts, but not use any mechanical devices or vehicles for said purpose.
10. Use of the City's logo(s), seal, flag or insignia by lessee in any manner is strictly prohibited. A violation of this Policy may result in cancellation of lessee's permit.
