# **PY 2019 Farmington Hills CARES Act Amendment**

# **Annual Action Plan 2019/2020 Substantial Amendment**

### **Executive Summary**

#### 1. Introduction

**COVID-19 Background** - In December 2019, a new coronavirus known as SARS-CoV-2 was detected causing outbreaks of the coronavirus disease COVID-19 that has now spread globally. The first reported case in the United States was in January 2020 and by March 2020 the World Health Organization declared the COVID-19 outbreak a pandemic and the federal government declared a national emergency. Many states, including Michigan, declared a state of emergency.

**Federal Relief Response** - On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136 was signed by the President of the United States. This made available \$5 billion in Community Development Block Grant Coronavirus (CDBG-CV) funds, \$4 billion in Emergency Solutions Grant Coronavirus (ESG-CV) and \$65 million in Housing Opportunities for Persons with AIDS (HOPWA) supplemental funds to respond to the growing effects of the historic COVID-19 public health crisis.

The Department of Housing and Urban Development (HUD) informed the City of Farmington Hills that CARES Act funding would be allocated to the jurisdiction based on the existing entitlement formulas for the three programs. City of Farmington Hills receives annual federal funding for community projects that benefit low-to-moderate income residents through the CDBG program. The CDBG program aims to provide decent housing, a suitable living environment, and expanded economic opportunities for City of Farmington Hills residents. City of Farmington Hills received a special allocation of funds for the Community Development Block Grant Coronavirus (CDBG-CV) to be used to prevent, prepare for, and respond to the COVID-19 pandemic (coronavirus). Further guidance defining what qualifies as CDBG-CV response and other information may be forthcoming from HUD but these funds are to respond to the growing effects of this historic public health crisis. The CARES Act funds have been allocated to the City of Farmington Hills in the following amount: \$210,412 (CDBG-CV) supplemental allocations.

The CARES Act also authorized the HUD Secretary to grant waivers and alternative requirements related to the use of CDBG-CV funds, including the suspension of the 15 percent cap on funding for public services; reducing the public comment period for consolidated plan and action plan amendments to five days, and allowing the option of virtual hearings. To expedite and facilitate the use of these funds the City of Farmington Hills will, as necessary, avail itself of the additional flexibility being provided, request available waivers, and request permission to use alternative requirements of statues and regulations

with the use of CDBG-CV funds. All eligible CDBG activities must meet one of the following national objectives: (1) Benefit to low- and moderate-income (LMI) persons; (2) Aid in the prevention of slums or blight; and (3) Meet a need having a particular urgency. The City of Farmington Hills may undertake CDBG-CV eligible activities to meet needs resulting from declared disasters or emergencies under any one of the three CDBG national objectives. All activities funded must still meet the eligibility and national objective requirements of the CDBG program.

The City of Farmington Hills is committed to deploying federal, state, and local resources to help. City of Farmington Hills is part of the Oakland County HOME Consortium which has coordinated efforts to develop an emergency and public health response to prevent, prepare for, and respond to COVID-19. City of Farmington Hills has developed a comprehensive operational and funding plan utilizing CDBG-CV funds which WILL BE ADOPTED by the City of Farmington Hills City Council on June 8, 2020. The plan and corresponding budget included CDBG-CV funding allocations. City of Farmington Hills seeks approval of a Substantial Amendment to the Program Year (PY) 2015-2020 Consolidated Plan, PY 2019 One-Year Action Plan and Citizen Participation Plan in order to submit its COVID response plan to HUD. The 2015-2020 Consolidated Plan and the 2019 One-Year Action Plan was approved by RESOLUTION R-19-19 on May 13, 2019. The One-Year Action Plan amendment identifies proposed activities for the expenditure of CDBG-CV to address the COVID -19 crisis. Newly funded activities are scheduled to begin implementation as soon as agreements are executed. The substantial amendment funding must be committed prior to September 30, 2022.

#### **Summary of Citizen Participation Process and consultation process**

The Citizen Participation Plan was amended to utilize the Public comment waiver. A public meeting, public notice and phone conversations were utilized to solicit participation. The Farmington Hills City Council held a virtual public hearing on June 8, 2020. One representative of YMCA at the meeting spoke on this item and one letter of support was received from Salvation Army. The City of Farmington Hills posted a comment period from May 28, 2020 to June 9, 2020 to meet the minimum 5 day public comment period. The Public Notice was published in the Farmington Observer, available via the city web page and hard copy via US Postal.

#### 5. Summary of public comments
